SUBJECT: NATIONAL DEWORMING CAMPAIGN FOR PRIVATE UNAIDED SCHOOLS.

Government of NCT of Delhi is set to conduct National Deworming Campaign from 23.04.2024 to 30.04.2024 (on all working days), with its implementation through the conventional platforms of schools and Anganwadi centres.

Directorate of Family Welfare, Department of Health and Family Welfare, GNCTD has been successfully implementing National De-worming Programme in all Govt. & Govt. Aided schools of Delhi Government and Private Un-aided Recognised School and local bodies. Though, the coverage of this programme in the October, 2023 round was 68% in respect of Private schools and Directorate of Family Welfare aimed at implementing the said National De-Worming Programme in all Private Schools of Delhi and to achieve 100% coverage in the April, 2024 round.

Therefore, all the Heads of Private Unaided Recognized Schools under Directorate of Education, Govt. of NCT of Delhi are directed to extend necessary support to the campaign and to adhere to the guidelines/instructions issued by School Branch vide Circular dated 18.04.2024.


